- **Docket Calls:** All attorneys of record must attend docket calls unless good cause can be shown, and leave is granted by the Court in advance of the docket call. Judge Ridley's office must be contacted prior to the day of the docket call if you wish for your case to be passed. Calling the clerk will not suffice to pass or set your case. If counsel is not present to announce the status of a case, that case will either be set for trial on a date determined by the Court or dismissed for lack of prosecution. The motion docket will start immediately after docket calls.
